



**Doodle Health Warranty, Purchase Agreement and Spay and Neuter Contract**

This contract is between 4E Kennels and:

**Seller's Responsibility:**

1. 4E Kennels guarantees the puppy is in good health, has had it's first age appropriate immunizations, has been dewormed, and has his/her health certificate at the time the buyer takes possession. The buyer has **three business days** to take the puppy to a veterinarian for an examination. If the puppy is found to be in poor health, the buyer has the option of returning the puppy to the seller, at buyer's cost, for a full refund. The buyer will provide a written statement from a licensed veterinarian clearly stating defect or illness. If the puppy is not taken to a licensed veterinarian within the three business days, the health warranty is void.

2. 4E Kennels provides this warranty for two years after the date of sale against any debilitating congenital defects. In the event the puppy exhibits symptoms of a suspected debilitating congenital defect, the buyer must supply any requested veterinary records to the seller within seven days of informing the seller of the defect. 4E Kennels has the right to require a second opinion from a veterinarian of the seller's choice at the seller's expense. If the puppy is euthanized or in any way disposed of, without a second opinion from the seller's veterinarian, the buyer waives all rights to a replacement puppy. Breeder guarantees that all age appropriate precautions have been taken with parents to ensure puppy will be healthy and will not have genetic issues that will cause less than a normal life. In the event of a proven pre-existing life threatening medical condition, or a proven genetic disorder that would prevent the puppy from fulfilling the intended purpose it was purchased for, the puppy is covered by this guarantee for a period of one year and 2 years for severe hip dysplasia. Any health issues must be confirmed by a licensed veterinarian, and the Breeder reserves the right to request a second opinion. It is to be clearly understood, that the Breeder does NOT, under any circumstances, accept responsibility for any veterinarian and/or health care expense.
3. This warranty does not include viral illnesses, infections, improper bites, stress related illness, hernias, hypoglycemia, parasites, Giardia or Coccidiosis. It also does not include any illness due to the ingestion of foreign objects, food, chemicals or physical injury.
4. If it is determined the puppy does have a genetic disorder (refer to #2) that is identified within two years of purchase, the buyer has the option of a replacement puppy of equal or lesser value from the next available litter. Your puppy need not be returned to us provided there is documented support of medical condition. Shipping fees will not be refunded, and if it becomes necessary to ship a replacement puppy, those fees are to be paid by the buyer. Breeder determines which puppy (of equal or lesser value) will be used as a replacement and the wait could be as long as 6-12 months.
5. If the puppy should die from a suspected congenital defect within the 24 months of its date of purchase, an autopsy must be performed at the buyer's expense by a licensed veterinarian acceptable to the seller's own veterinarian. If the autopsy shows a congenital defect as the reason of the death, the seller will provide another puppy of equal value to the buyer. A written statement from the Veterinarian must be provided. This warranty is void in the event of an undetermined or inconclusive diagnosis.

6. No warranties or guarantees, expressed or implied, are made under this contract except as stated.
7. This warranty is non-transferable.

**Buyer's Responsibility:**

1. The buyer agrees to pay 4E Kennels a total sum of \$ \_\_\_\_\_. This fee does not include shipping. If shipping is required, buyer agrees to pay \$\_\_\_\_\_ for shipping, which includes a travel crate and health certificate.
2. The buyer bears all costs relating to the sale of the above animal, including transportation. The risk of loss or injury to the above animal is on the buyer at all times after the dog leaves the seller.
3. The buyer agrees that their Goldendoodle will be housed indoors.
4. 4E Kennels highly recommends feeding their Goldendoodle only a premium complete quality food.
5. The buyer agrees to keep their Goldendoodle at a healthy weight.
6. The buyer agrees to make and keep annual veterinary appointments for their Goldendoodle, keep all immunizations current according to the guidelines of the American Veterinary Medical Association and properly administer heartworm preventative medication (if living in an area of concern).
7. The seller highly recommends providing basic obedience training with their Goldendoodle puppy within the first year of owning their dog.
8. The buyer agrees to postpone strenuous, repetitive exercise until after their Goldendoodle is over one year of age.
9. The buyer agrees to contact 4E Kennels immediately if the buyer determines they are unable to keep their Goldendoodle for any reason. The buyer and 4E Kennels will determine how the dog will be rehomed.
10. The buyer agrees to **never** place their Goldendoodle in a shelter, pound, or similar facility or research laboratory.

**Spay and Neuter Contract:**

1. Spaying/neutering by a licensed, reputable veterinarian is required on the above puppy at 12 months of age. Proof of this, in the form of a Certificate of Spay/Neuter from the Veterinarian, must be forwarded to 4E Kennels by the time the puppy reaches 14 months of age. If 4E Kennels does not receive this within this time, this contract will become null and void.
2. It is understood that at the time of sale that this said puppy is not to be used for breeding. It is a representation of its breed and it is structurally and temperamentally suited for a companion and/or working dog. It is being sold as a pet without breeding rights.

**NuVet Supplements:**

See addendum that adds an extension of 6 months on to the health guarantee if your puppy is kept on NuVet supplements for duration of this warranty and guarantee.
